

Nebraska Schools Reopening Assistance

DHHS Offers Many Ways to Keep Our Schools Open

The NDHHS Division of Public Health supports schools in their efforts to ensure healthy students and to keep schools open in the 2021-2022 school year. This document describes how schools can request assistance.

Supplies

DHHS can provide the following supplies directly to Local Health Departments and/or school districts:	
<ul style="list-style-type: none">➤ Child-sized masks➤ Tissues/Kleenex➤ Rapid antigen tests (refer to "Testing" section below)➤ HEPA Filter Machines & Replacement HEPA Filters➤ Filters for existing HVAC systems	<ul style="list-style-type: none">➤ Hand sanitizer➤ Disinfectant wipes➤ School bus metal - alcohol➤ School bus seat/plastics - disinfectant spray

Testing

If your school is experiencing an outbreak, you may request assistance with testing. An outbreak is determined by the school in conjunction with the local health department. *If you think you could be experiencing an outbreak, please contact your local health department.* DHHS will send a strike team and arrange for the shipping of specimens to the public health lab. DHHS can also supply rapid antigen tests directly to schools.

CLIA Waiver – If a school is testing onsite rather than obtaining testing through the LHD or through a 3rd party, the school is required to have a CLIA waiver. E-mail for more information: DHHS.AcuteCareFacilities@Nebraska.gov
