Vaccinating Teenagers and COVID Vaccine Map for Southwest Nebraska

Southwest Nebraska Public Health Department (SWNPHD) received 100 doses of Pfizer COVID-19 vaccine this week and is quickly using the supply by vaccinating teenagers. Pfizer is the only vaccine available at this time for persons aged 16 and 17 years and there are many families that have been waiting for an opportunity for their teens to get protection from COVID-19, because they are at higher risk due to their occupation, sports activities, a health condition, or other reasons. SWNPHD and the following partners are administering the Pfizer vaccine in southwest Nebraska:

- Chase County Clinic – Imperial
- Dundy County Hospital and Quality Care Clinic – Benkelman
- Mark’s Pharmacy – Cambridge
- U-Save Pharmacy – Ogallala
- Southwest Nebraska Public Health Department – McCook

Nebraska residents can register to receive COVID-19 vaccine at vaccinate.ne.gov. Currently, persons are being vaccinated in one week or less. If you do not have computer access, please call 308-345-4223 or one of the local vaccination partners to register. You can also call to schedule an appointment or to see if that location is accepting walk-ins.
