### **Tax Exemptions**

- Range of exemptions to taxes in the state of Nebraska
- Sales Tax most predominant
  - Educational Institutions
  - Non-profit Organizations
  - Religious Organizations
  - Governmental Units



## What is a "Governmental Unit"?

- State of Nebraska
- Municipality
- County or township
- Other entities such as, Natural Resource Districts, Airport Authorities, etc.
- Nonprofit corporation formed by an exempt governmental units



## What about Public Health Departments?

- No specific exemption for public health departments HOWEVER
- An organization established under the Interlocal Cooperation Act is exempt
   only if it is comprised entirely of exempt governmental units
- Must have applied for and received a Nebraska Exempt Organization
   Certificate of Exemption from Nebraska Department of Revenue



### **P-Card Exemptions**

- State of Nebraska Purchasing Card allows government employees to make tax-exempt purchases
- Purchases made for work using any other card are considered employee
   purchases and are not exempt





### Tax Exemptions (Hotels, Lodging, etc.)

Governmental units also exempt from lodging taxes

Check One Purchase for Resale (Complete Section A.) Exempt Purchase (Complete Section B.)

- Exempt organizations must provide the hotel or lodging establishment with a Form 13
- Employees personally paying for lodging, even if reimbursed, are not eligible for exemption

# LB 692 – Nebraska Health Care Funding Act

- Passed in 2001, Amended Neb. Rev. Stat. 71-1626 71-1627
- Provided funding to local public health departments to carry out core public health functions:
  - Assessment,
  - Policy Development, and
  - Assurance
- Carried out by:
  - Emphasizing services to prevent illness, disease, and disability;
  - Promoting effective coordination and use of community resources;
  - Extending health services into the community, including public health nursing, disease prevention and control, public health education, and environmental health services



#### LB 692 Continued

 Sections 5 and 6of LB692 explicitly called for counties to come together and develop or join interlocal agreements in order to form district public health departments



### Interlocal Cooperation Act

- Neb. Rev. Stat. 13-801 13-827
- Allows local government entities or other public agencies to contract with each other to simplify or consolidate processes
- Intended to increase government efficiency



### ICA - Who?

- Neb. Rev. Stat. 13-803
- Can be an agreement between any
  - County
  - City
  - Village
  - School District
  - State or Federal Government Agency
  - Sanitary and Improvement District
  - Other Municipal Corporation or Political Subdivision of Nebraska
  - Any Political Subdivision of Another State



### ICA - Why?

- Ease of conducting public operations
  - Collaborations relating to maintenance such as snow removal or landscaping
  - School districts sharing facilities with other public entities
- Creation of Public Health Department
  - County Commissioners make an agreement to create a new legal entity such as a health department
    - SWNPHD agreement between Chase, Dundy, Frontier, Furnas, Hayes,
       Hitchcock, Keith, Perkins, Red Willow Counties



## ICA – Agreement Requirements

- Neb. Rev. Stat. 13-804
- These agreements must outline:
  - Duration of agreement;
  - Purpose of the agreement;
  - How it will be financed and budgeted;
  - How it can be terminated:
  - Whether and how any taxes will be levied as part of the agreement;
  - Whether a separate legal entity will be created by the agreement, and how it will be structured; and
  - "Any other necessary and proper matters."



### ICA – Legal Entity Powers

- Neb. Rev. Stat. 13-804
- Any entity created by an ICA has the power to:
  - Sue and be sued;
  - Have a seal;
  - Make and execute contracts and other legal instruments,
  - Make, amend, and repeal bylaws, rules, and regulations
